Potential Human Health Effects

Occupational Exposure

Potential for occupational exposure exists during manufacture, in unloading, storage, staging and transfer operations, while charging reaction vessels and while performing maintenance at facilities using Lewatit® MDS 1268 K / 310 in the manufacture of filtration products. A much lower potential for exposure exists in facilities using Lewatit® MDS 1268 K / 310 in closed manufacturing processes by trained personnel.

Employee Training

Workers handling Lewatit[®] MDS 1268 K / 310 should be trained to implement proper handling procedures and to understand the potential health and physical hazards of this product. Good general ventilation should be sufficient to control worker exposure to airborne contaminants. Respirator use must be based on known or anticipated exposure levels, the hazards of the product and the safe working limits of the selected respirator. In addition, LANXESS recommends gloves, safety glasses with side shields, suitable protective clothing and footwear be worn when handling Lewatit[®] MDS 1268 K / 310.
