Main version

- Installation possible for 'All users' using administrative rights
- Default installation location is C:/Program Files (x86)/ LewaPlus2/
- Installation possible 'Only for me' using standard user rights
- Default installation location is C:/Users/%username%/ AppData/Local/Programs/LewaPlus2
- User data will be stored in
 - User database/settings C:/Users/%username%/
 AppData/Roaming/LewaPlus2
- Manually downloaded additional documents
 (e.g. product data sheets): C:/Users/%username%/
 AppData/Local/LewaPlus2

Portable version

- Default installation location is C:/Users/%username%/ LewaPlus2-Portable
- User data will be stored in the installation location
- The portable version can be installed on USB thumb drives or other external data storage devices

Internet/network access

- All LewaPlus® features requiring internet access are optional (data sheet download, automatic software update, currency conversion rates update)
- LewaPlus® core features can be used without network access

Data management

Project and design data

- Projects are stored locally in the user database
- Data can only be exchanged by exporting designs as .lxf (LewaPlus exchange file) or PDF formats. There is no automatic data upload to LANXESS.
- Product and safety data sheets (optional)
 - LewaPlus® offers the possibility to download data sheets in PDF format from our web server. The downloaded files are stored in the user data directory according to the chosen setup variant. Downloads have to be performed manually by the user.
- Automatic update (optional)
 - -The automatic update feature can check for new versions of LewaPlus® and download the setup file from our web server. This feature is optional and can be disabled. Updates can also be performed manually by downloading the setup directly from our website.
- Currency conversion rates update (optional)
 - Cost can be calculated using a variety of currencies.
