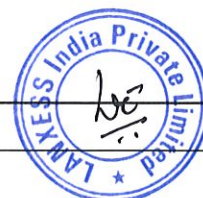

Globe Bio care - Authorization is valid up to 15/07/2023 2) Disinfection : Only Laboratory and highly infectious waste shall be pre-treated onsite before sending for final treatment or disposal through a CBWTF operator. (e.g. used needle is burnt and then cut before disposal). 3) Segregation : All generated waste is segregated onsite by its category defined as per BMW rules, 2016. (Dedicated color coded storage bins for each category of waste with proper label.) 4) Immunization : All the staff involved in handling Bio medical waste are immunized by vaccine and records are maintained at OHSC. (Hepatitis B and Tetanus). 5) Plant Visit : Committee visited service provider plant on 13/07/2018. 6) Bar Code : System for implementation of barcoded bags to be implemented by the vendor, was discussed. Vendor has already procured the machine for that but the system is yet to be implemented. 7) Register : Day to Day generated bio medical waste is weighed at OHSC and record is maintained at OHSC. 8) Training : All OHSC staff professionally trained on how to handle Bio Medical Waste And What Precaution to be taken while handling the same by FMO.</p>

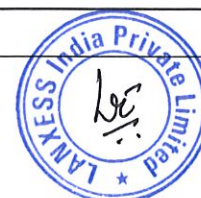
