Developing with Japan

LANXESS' roots in Japan trace back to Bayer's introduction of dyes in 1886. Following its independence, the company's Japanese subsidiary LANXESS K.K. was established to import and sell specialty chemicals, serving industries such as automotive, electronics, construction, and agriculture. The Toyohashi site, home to the Rhein Chemie business unit, operates a state-of-the-art production facility for rubber additives, while the Kawasaki technical center supports microbial control services for the Material Protection Products business unit.

In 2015, LANXESS K.K. strengthened its operations by merging with Rhein Chemie Japan Co., Ltd., enhancing its capabilities in rubber
