Supply Conditions KELTAN ELASTOMERS

Order quantities

- All prices are based on FTL (Full Truck Load) or FCL (Full Container Load) deliveries.
- FTL/FCLs are defined by:
 - The maximum allowed truck/container load on route to the delivery address
 - The maximum number of pallets to be loaded on a truck/container
 - Any order above 18Mt will be considered a FTLYour local Sales Representative could give you further details
- An order can be a combination of Keltan grades. Minimum order quantity per grade is one full pallet or one packaging unit. Minimum order quantity per order is 5 pallets or five packaging units (combined ex Geleen / Marl warehouses)
- For less than full truck/container load deliveries (LTL or LCL) following surcharges are applicable (combined ex Geleen or Marl warehouses):
 - For order quantities between 10 mt and FTL/FCL: € 75/ mt
 - For order quantities between 5 mt (or 5 pallets) and 10 mt : € 150 /mt
- Orders for Marl and Geleen can not be combined in one truck. However, if an FTL/FCL of combined Marl and Geleen product is ordered, no surcharges will be applied.

Delivery

- For all deliveries the latest version of the INCO-terms apply
- The lead time for regular orders (road transport) received before 12:00 CET, is 2 working days, excluding transportation time. Your Sales Representative could inform you about your specific transportation lead time.
Example:
 - Orders received on working day 1 before 12:00 CET
→ loading on workday 3
 - Order received on working day 1 after 12:00 CET
→ loading on workday 4
- For rush orders (i.e. delivery with shorter lead time), if practically possible, a € 400 surcharge and additional transportation costs will be added to the invoice amount
- Block times, limiting opening hours of receiving warehouse, are acceptable as long as the opening hours are at least 50% of a working week. Block times will extend the order lead time by one working day.



Order Changes and Cancellation

- Orders can be cancelled until 5 working days before day of loading
- Orders can be changed on grade mix or delivery date until 5 working days before day of loading. Thereafter the order change will be considered a rush order/change for which additional costs will be charged (€400)
- Orders shipped directly from USA cannot be cancelled or changed after loading in the USA.

Transport documentation

- Documents accompanying the delivery fulfill country specific legal requirements
- No customer specific documents can be included

Payment conditions

- Invoices and payment terms are denominated in Euros. Surcharges are also denominated in euros and specified separately on the invoice
- Payments can be done via Bank Transfer. Bank Account details are printed on the actual invoice.
